The tuition fee is \$1,500. As a valued supporter, members of the Irving-Las Colinas Chamber of Commerce will receive a discounted tuition rate of \$1,400. The tuition fee covers costs for leadership seminars, meals, program materials and meeting functions. Once participants are selected, tuition must be paid by Friday, August 20, 2021. Tuition is non-refundable after Friday, September 3, 2021. Failure to meet payment deadline will result in candidate not being admitted to the class.
